Diagnoses may include neurological, developmental, mental health, and orthopedic conditions. Level of care, funding availability, and other considerations determine appropriateness for and type of program and services. Specific etiology, injury level, completeness, and co-morbidities as it pertains to spinal cord injuries are delineated based on the individual's ability to meet admission criteria.  Stable, free from acute infection or fever, non-ventilator dependent, and requires no advanced medical care. Diagnosis of concussion, loss of consciousness less than 30 minutes, unremarkable imaging, post traumatic amnesia less than 24 hours.
